APPLICATION FOR LITTER REGISTRATION

Please include the following with the Application:

- A. If both sire and dam are International Miniature Australian Shepherd Club (IMASC) registered:
 1. If not already submitted to IMASC, a copy of EYE and HIP clearances on sire and dam for Breeder of Merit Program, if available and title certificates, if you wish titles to be included on future pedigrees; and
 2. Registration Fee (See reverse of Application)
- B. If either sire or dam is NOT or both sire and dam are NOT IMASC registered, but registered with MASCA, NAMASCUSA, NSDR (Australian Shepherd or Miniature Australian Shepherd), AKC and/or ASCA:
 1. A copy of the non-IMASC registered dog(s) MASCA, NAMASCUSA, NSDR, AKC, and/or ASCA registration certificates.
 2. A photograph of the non-IMASC registered dog(s).
 3. If not already submitted to IMASC a copy of EYE& HIP clearances on sire and dam for Breeder of Merit program, if available and title certificates, if you wish titles to be included on future pedigrees; and
 4. Registration Fee (See reverse of Application)
- C. Litters for which both sire and dam are MASCA, NAMASCUSA, NSDR, ASCA, AKC (Australian Shepherd Only) are not eligible for registration unless one or both parents are registered with IMASC, in which case the IMASC registration number should be used for the application. Please fill out the form for Individual Registration if you wish to register a small Australian Shepherd with IMASC.
- D. Age: Sire and Dam must be 12 months or older at date of mating for litter to receive Full Registration. If either or both sire and dam are not yet 12 months old but are at least 9 months old of the date of mating, Provisional Registration shall be awarded. A Provisional Registered dog must receive passing EYE and HIP clearances at 2 or more years of age and pay a \$50.00 Change of Registration Fee in order to receive Full Registration and to parent a register able litter. A Provisionally Registered dog may compete in all IMASC events. If either or both sire or dam is under 9 months of age on date of mating, litter is not registerable.
